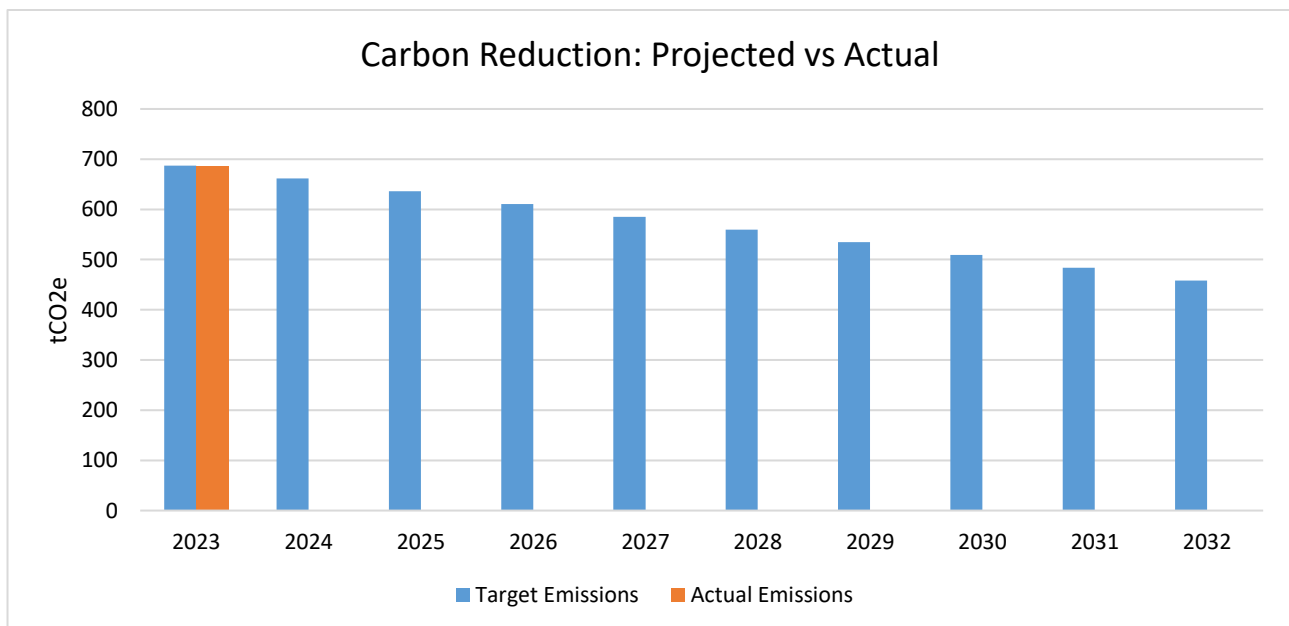

We project that carbon emissions will decrease over the next five years to 559.9 tCO₂e by 2028. This is a reduction of 18.5 %
